City Council Regular Meeting Minutes

Call to Order

Mayor Otto called the regular meeting of the LeRoy City Council to order at 6:00 PM. The Pledge of Allegiance was recited.

A quorum was present.

Approval of Agenda

Mayor Otto presented the proposed agenda for the February 2, 2026, meeting.

Council Member Yeager moved to amend the agenda to include a ten (10) minute Executive Session under the Mayor’s Report for the purpose of discussing personnel matters of non-elected personnel pursuant to K.S.A. 75-4319(b)(1). Council Member Rolf seconded the motion.

Motion carried 5-0.

The agenda, as amended, was approved.

Approval of Previous Meeting Minutes

The Council reviewed the minutes of the January 5, 2026, regular meeting.

Council Member Yeager moved to approve the minutes with one correction, changing the wording from “acting mayor” to “mayor.” Council Member Bowen seconded the motion.

Motion carried 5-0.

The Council then reviewed the minutes of the Special Meeting held on January 19, 2026.

Council Member Meyers moved to approve the Special Meeting minutes as presented.
Council Member Tyler seconded the motion.

Motion carried 5-0.

Public Comment

Mayor Otto called for public comments. No public comments were made.

Mayor's Report

Water Plant Roofing Bids

Mayor Otto presented two bids received for roofing repairs at the City Water Plant:

Strawder Construction – \$7,416.77

A&L Builders – \$5,463.23

The Council discussed the bids and associated costs. After consideration, Council Member Meyers moved to approve the bid from A&L Builders in the amount of \$5,463.23. Council Member Bowen seconded the motion.

Motion carried 4-0, with Tyler abstaining.

Dog Complaint

The Council discussed a complaint regarding a dog within city limits, including the circumstances surrounding the issue. No formal action was taken at this time.

Water Leak Forgiveness Request

The Council considered a request from Mr. Hegwald for forgiveness of charges related to a water leak.

After discussion, Council Member Yeager moved to deny the request. Council Member Bowen seconded the motion.

Motion carried 5-0.

Ball Director Cost Share

Mayor Otto recommended approval of a cost-sharing arrangement with the City of Gridley in the amount of \$750.00 for the Ball Director position involving Laurie Gourackie.

Council Member Rolf moved to approve the \$750.00 cost share. Council Member Tyler

seconded the motion.

Motion carried 5-0.

Executive Session

Council Member Yeager moved that the City Council recess into executive session for ten (10) minutes pursuant to K.S.A. 75-4319(b)(1) for discussion of personnel matters of non-elected personnel in order to protect the privacy interests of the individual(s) to be discussed. The open meeting will resume at 6:29 PM. Those present in the executive session will be the Mayor, City Council, City Attorney, City Supervisor, and City Clerk. Council Member Rolf seconded the motion.

Motion carried 5-0.

The governing body recessed into executive session.

The governing body returned to open session at 6:29 PM. No binding action was taken during the executive session.

Appointment of Dog Catcher

Following discussion, Council Member Yeager moved to approve Aaron Copeland as City Dog Catcher. Council Member Bowen seconded the motion.

Motion carried 5-0.

Approval of Warrants

The Council reviewed the proposed warrants/bills presented with the agenda.

Council Member Tyler moved to approve the warrants as presented. Council Member Meyers seconded the motion.

Motion carried 5-0.
